A question from a couiple of members about turning in our Semi-Annual Audit, the answer is we do not have a Semi- Annual Audit, only an Annual Audit for Assemblies. That is due August 1st of each year for the year just ending. Still looking for a Chaplain.

Comptroller's Report; Bob reported that members have been paying dues most has been reported in tonights Treasurer's Report , but a few more came in today and this evening. They will be on the next report. 31 members still owe and 12 of them also owe for last year. Several transfers are still in process.
